

\*\*Limited Time Offer (17-, 18-, 19-, 20-) Codes\*\* - Often, at the suppliers' requests, Special Order codes change to LTO codes and then may return as Special Order codes. This necessitates using different code numbers. Ask the supplier rep or broker rep if you need assistance.

\*\* Pricing Reports \*\* - Pricing is only changed at the suppliers' request and those changes are effective during the next pricing quarter for existing, active products. With recent concerns regarding the tariffs and their impact on pricing, it is possible August pricing may have changed after the pricebook was sent to the printer.
