

****ACH Information**:** A spreadsheet containing the suppliers' ACH information is available on the Boards' website under Miscellaneous Information on the homepage (with the Remittance Address Reports). This is a more secure method to share this information. If you have additional suppliers' ACH information not included on this list, please share it with us. When making ACH payments, please remember to send the supplier an email with the remittance information, as they need this information to properly apply the payment. Suppliers are added to the spreadsheet whenever they make the information available to the Commission. New additions and updates are indicated with a date in the far right column.

****Limited Time Offer (17-, 18-, 19-, 20-) Codes**** - Often, at the suppliers' requests, Special Order codes change to LTO codes and then may return as Special Order codes. This necessitates using different code numbers. Ask the supplier rep or broker rep if you need assistance.

**** Pricing Reports **** - Pricing is only changed at the suppliers' request, and those changes are effective during the next pricing quarter for existing, active products. It is possible pricing may have changed after a pricebook was sent to the printer. You can create price change reports on the public website using this link <https://www.abc.nc.gov/pricing/pricing-reports>. Other reports of interest are also available on this page. The downloadable Pricing Reports available on the Boards' website are up to date.
