1 14B NCAC 15B .0114 is proposed for adoption as follows: 2 3 14B NCAC 15B .0114 ISSUANCE OF SUBSEQUENT NONPROFIT LIMITED SPECIAL OCCASION 4 PERMIT AND SPECIAL ONE-TIME PERMIT 5 (a) A nonprofit organization, issued a limited special occasion permit pursuant to G.S. 18B-1001(9) or a special one-6 time permit pursuant to G.S. 18B-1002(a)(2) or (a)(5), may apply for the issuance of a subsequent similar permit in 7 accordance with G.S. 18B-903A within 18 months of the date of issuance of the initial permit. 8 (b) A permit may be issued pursuant to this Rule no more frequently than once a month within 18 months of the 9 issuance date of the initial permit. 10 (c) After 18 months of the date of the issuance of the initial permit, a person seeking a limited special occasion permit 11 or a special one-time permit shall submit an application for a new initial permit. 12 (d) As used in this Rule, "initial permit" means the first limited special occasion permit or special one-time permit 13 issued to the same individual for the same location on behalf of a nonprofit organization pursuant to G.S. 18B-903 within the previous 18 months.
