### NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, December 10<sup>th</sup>, 2025 and ratified 84 hearing cases that resulted in penalties in excess of \$100,800 and/or imposition of suspensions of permits for three days or more. Fines are due on or before January 2<sup>nd</sup>, 2026, and suspensions begin January 9<sup>th</sup>, 2026.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Bond Brothers Beer Company, LLC T/A Bond Brothers Beer Company; Standard Beer & Food, LLC T/A Standard Beer & Food; Fortnight Brewing, Inc. T/A Fortnight Brewing; Seirios, LLC. T/A Starpoint Brewing; and Whitney Baker.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for The Three Ring Brewing Co., LLC T/A Hi-Wire Brewing; Joyful Noise Hifi, LLC; Christopher Frosaker; and Bryna Frosaker.

The Commission approved an amended exemption order pursuant to [§18B-1116\(b\)](#) for Suffolk Punch Holdings, LLC; Noble Smoke, LLC; Bossy Beaut's Chicken Shack (I, II, 3, 4, 5, 6, 7), LLC; Harriet's Hamburgers BB, LLC; Harriet's Hamburgers II, LLC; Harriet's Hamburgers VII LLC; Glen D. Cherry; and Charles C. Ricks.

The Commission approved a proposed ABC store location at 10340 Old Blackwell Road in Belville, as requested by the Belville ABC Board. This store will replace the ABC store at 44 River Road Southeast in Belville.

The Commission continued the NC Private Protective Services Board's request to amend 14B NCAC [15B.0103](#) and [15B.0210](#) until the January 2026 Commission meeting.

The Commission adopted proposed amendments to 14B NCAC [Subchapter 15C](#), Sections .0400 - .0600 for proposal to the Rules Review Commission.

The Commission confirmed the next monthly meeting will be held at the NC ABC Commission (400 E. Tryon Road, Raleigh, NC 27610) on Wednesday, January 14<sup>th</sup>, 2026, at 10:00 am.
