## NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, October 8<sup>th</sup>, 2025 and ratified 102 hearing cases that resulted in penalties in excess of \$122,400 and/or imposition of suspensions of permits for three days or more. Fines are due on or before October 31<sup>st</sup>, 2025, and suspensions begin November 7<sup>th</sup>, 2025.

The Commission approved an exemption request pursuant to §18B-1116(b) for Mountain Beverage, LLC T/A Appalachian Mountain Brewery; Modern Alchemist, LLC T/A Modern Alchemist; Laughing Hop, LLC; Craft Brew, LLC, and Hogan Holdings LLC.

The Commission approved an exemption request pursuant to §18B-1116(b) for Voodoo Brewing Company Inc T/A Voodoo Brewing Company (2 locations); Voodoo Licensing LLC; and Stamper Development Group, LLC T/A Voodoo Brewing Company.

The Commission approved a proposed ABC store location at 8930 East Franklin Street in Mount Pleasant, as requested by the Mount Pleasant ABC Board. This store will temporarily replace its current location at 8840 E. Franklin Street while a potential new store site undergoes renovation.

The Commission held a public hearing for proposed amendments to 14B NCAC <u>15B</u>, rules .1007 - .1008. The Commission also adopted proposed amendments to 14B NCAC <u>15C</u>, rules .0100 - .0300, except .0103, for proposal to the Rules Review Commission. If the Rules Review Commission adopts the proposed amendments and there are no objections, they will take effect January 1<sup>st</sup>, 2026.

The Commission rescinded its revocation of permits for Brothers Corner Mart in Newton Grove pursuant to §18B-900(a)(5).

The Commission confirmed the next monthly meeting will be held at the NC ABC Commission (400 E. Tryon Road, Raleigh, NC 27610) on Wednesday, November 5<sup>th</sup>, 2025, at 10:00 am.
